


Background

Gaelscoil & Naíscoil Éanna is seeking to deliver a new 7No. classroom primary school and nursery unit to replace the existing school on the Hightown Road, Glengormley. Given the site constraints of the existing school, along with the expansion size criteria to deliver a new school and nursery to required Department of Education standards, it is not physically possible to deliver the new school and nursery on its present site. It therefore requires a new site.

Locatio

Gaelscoil & Naiscoil Eanna is seeking to deliver the proposed development on a new site very close to the existing school/nursery, on lands circa 245 metres south of the existing St. Enda's GAC, Hightown Road, Glengormley. The proposed site presently consists of an agricultural field. The proposed school and nursery building is proposed to be located to the west of the St. Enda's GAC pitch and sports hall development.



Reason for New Public Consultation

This public consultation supersedes that under Council reference number LA03/2021/0364/PAN submitted on the 20th April 2021 and accepted by Council on 23rd April 2021. The reason for this new PAN is because following internal design review with the Department of Education ('DE') and the Education Authority ('EA'), there have been design updates to the proposed scheme. To summarise, the updated proposals now include:

- Accommodation of a full school meals area/kitchen facility, which was not previously included by DE/EA in their budgeting/parameters for this project. By introducing a dedicated services access immediately to the lef side on entering the site, this effectively separates service vehicles from all other vehicles using the site. The change of level and proposed landscaping will screen this service area from the access road and capark.
- Pupil set-down located on the levelled upper part of the site, with the chool building reoriented to better address this area.
- The overall site area has therefore increased southwards. This is a result f addressing the slope within the existing site, whilst seeking to avoid the se of retaining structures. This has been achieved by limiting the gradient fany banked areas to a slope of 1 in 3.
- Increased useable green play area, including a MUGA, in the southern extended area of the site, which brings the overall site's usable areas in line with the schedule of accommodation in the current DE guidelines for a proposed new 7No. classroom school and 1No. groom nursery unit.

liven these design changes, there has been an increase in the proposed evelopment's site area, necessitating a new Pre-Application Community onsultation ('PACC').

Details of School/Nursery Building

The proposed development seeks to provide a single storey primary school and nursery unit building. The school and nursery will comprise: 7No. classrooms; a playroom, a multi-purpose hall and a library. It will also include several additional ancillary rooms, including administration and office spaces, student and staff toilets, external and internal storage areas, resource areas, school meals accommodation areas, multi-purpose rooms, plant areas and general circulation space. There will also be secure outdoor play space.

The orientation of the school and nursery along with the natural slope of the landform, shelter it from prevailing south westerly and cold northernly winds Classrooms face into the secure playground area with ancillary accommodation facing into public areas The multi-purpose hall is accessible from the public area to allow it to be used after school hours for community events.

Landscapir

Blocks of planting will be carefully positioned to provide an attractive local landscape setting for the school building with planting softening and framing views from the main entrances to the school building.

Access and Parking

Access is proposed to be taken via the existing road to Hightown Road, which is proposed to be extended to the school site. Car parking will be provided, including disabled spaces, along with a set down/pick-up circulation area and a bus parking space.
